Further the Income and funds of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way profits, interest, and dividend or otherwise.

The Trust is irrevocable.


24. ACTIVITIES OF THE TRUST:-


The activities of the Trust shall be only within India and its Union territories and shall not be extended anywhere outside India. The trust will not carry on any activities with intention of earning profit.


25. DISSOLUTION:-
